4. This may be treated as **Most Urgent**.

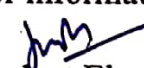

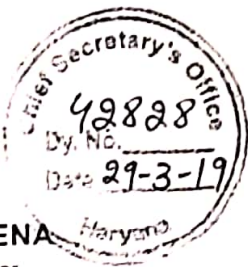
