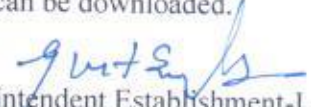
Subject:- Filling up the post of Superintendent in Haryana Right to Service Commission, Chandigarh.

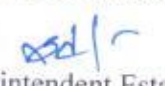
