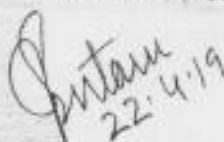

1	Stenographer Gr-I	In case of Deputation:- Officers possessing Bachelor Degree from a recognized University and holding : (i) Analogous post on regular basis in Central Government or State Government or Courts or Tribunals; or (ii) The Post of Stenographer Grade-I or equivalent post in Central Government or State Government or Courts or Tribunals with 10 (ten) years of regular service in the pay band-I, Rs. 5200-20200/- of grade pay Rs. 2400/- Level-4 in Pay Matrix and possessing speed of 80 words per minute in short hand (English/ Hindi). Desirable: Computer training of six months duration from a recognized institute. Note-1: The department officers in the feeder category who are in the direct line of promotional shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Note-2: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Govt. shall ordinarily be three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
