Subject: State Eligibility Test in Computer Appreciation and Applications (SETC) – list of exempted courses - clarification thereof.

Sir/Madam

I am directed to invite your attention to Haryana Government letter No. 42/164/2008-3GS-II, dated 19.9.2019 in which certain courses of minimum duration of 6 months from State Eligibility Test in Computer Appreciation and Application (SETC) were exempted. Some of the departments / employees have approached the General Administration Department for clarification on some issues which are being clarified as under:-

Sr. No.	Point raised by Departments	Clarification
1	Whether the Clerks who have been granted exemption in SETC Part-I on account of having completed a 3 months' computer course from HKCL/NIELIT etc. is valid after the issuance of instructions dated 19.09.2019 or not?	It is clarified that such employees who had acquired a certificate of 3 months' computer course from HKCL/NIELIT etc. before 19.09.2019 stand exempted. The six months' course prescribed by instruction dated 19.09.2019 shall be prospective in nature.
2	The Clerks who have completed 3 months' computer course from HKCL/ NIELIT etc. and approached their Department for grant of exemption certificate before 19.09.2019 and Department have not granted exemption till now, whether the same can be granted by the Department with retrospective effect now.	It is clarified that the Clerk who have completed 3 months' course before 19.9.2019 are entitled to exemption if the same has not been granted earlier.
3	The Clerks who have completed 3 months course from HKCL / NIELIT etc. before 19.09.2019 and paid the fees to the institute can claim for reimbursement of the fees Rs.3,500/- from the department or not.	It is clarified that the Clerk who have completed 3 months' course before 19.9.2019 are entitled to reimburse the fee of Rs. 3,500/-

4	The Clerks appointed before 19.09.2019 who have not acquired the certificate of computer course of 3 months before 19.09.2019, whether 3 months certificate of computer course acquired after 19.09.2019 is valid for exemption from SETC Part-I.	No, all the Clerks whether appointed before or after 19.09.2019 who have not completed minimum three months' computer course before 19.09.2019 have to now acquire the certificate of computer course of 6 months' or more for exemption from SETC Part-I.
