Sir,

Haryana State Telephone Board in its 1st meeting 2001
held on 16.2.2001 has decided that when an officer is transferred
from one department to another deptt. within Chandigarh or panchkula
his residential telephone should not be shifted and he should
retain the same residential telephone in his new place of posting.
In case the officer is transferred from the Financial Commissioner
Revenue's office to the Secretariat Administration and Vice-Versa,
the officer will retain the same residential telephone and payment
will be got adjusted through internal arrangements. However, these
instructions will also be applicable to the Heads of Departments
where an officer is transferred to Board/Corporations in Chandigarh
or Panchkula.
