Subject:- Policy for allowing the retention of official residential telephone to officers on their retirement.

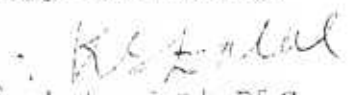
Sir,

I am directed to refer to Govt. circular letter No. 12/117/82-3 PS, dated 27 June 1983 and No. 12/15/95-3 PS, dated 6.4.95, on the subject noted above and to say that the matter regarding retention of official telephone at the residence of the officers who die in harness has been engaging the attention of the Govt. for some time. After a careful consideration, it has been decided that the officer who dies in harness should be treated at par with a retiring officer and the same facility be extended to his family on the same terms up to a period of four months from the date of death of the officer.

2. It is requested that these instructions may kindly be brought to the notice of all concerned officials/officers working under their control for compliance.

3. These instructions will take effect from the 1st Nov. 2003.
