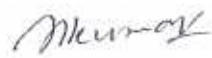

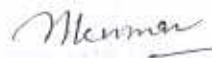

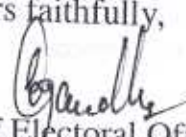

You are, therefore, requested that the hoarding/banners displaying the Govt. Achievements on the cost of public exchequer may be removed immediately and the other mode of publicity being adopted on Government Exchequer may also be stopped and ensure that the instructions issued by the Election Commission of India are followed strictly during the application of Model Code of Conduct.
