I am directed to invite your attention to above noted subject and to inform that Haryana Staff Selection Commission had announced the results for Group D recruitments for 18218 posts in various Departments.

2. Vide instructions even number dated 24.06.2019, all the Nodal Officers of all Departments/Boards/Corporations were directed to furnish the joining position in respect of their concerned Department within a week positively through special messenger.

The matter has been re-considered by the State Government and it has been decided to fill the various vacant posts of Group D which have arisen due to non-joining/Un-willingness/resignation of recommended candidates in some departments. The category wise data of such vacant posts is not available with the Haryana Staff Selection Commission as well as the Government.
