Subject:- Regarding joining of Group D posts in ESP Quota-clarification thereof with respect to the Hon'ble High Court's order dated 10.09.2019 in LPAs-1332 of 2019 (O&M) in CWP No. 23249 & other connected (O&M)- State of Haryana and another Vs Shankar and others.

Sir/Madam,

I am directed to invite your attention towards Hon'ble High Court's interim order dated 10.09.2019 passed in LPAs-1332 of 2019 (O&M) in CWP No. 23249 and other connected (O&M) - State of Haryana and another Vs Shankar and others. On the basis of said order, the Government instructions of even number, dated 17.09.2019 were issued vide which all the Departments/ Boards/ Corporations were directed that the services of all those employees, who got employment on the basis of their sports achievement, shall not be terminated on the ground of their failure to have produced the Sports Gradation Certificate under the new policy till 31.10.2019.

2. Now, various Departments are sending matter to General Administration Department (in General Services-I Branch) for clarification whether the candidates with old Sports Certificates would remain in service after 31.10.2019 and the benefit like salary can be given or not?

3. Accordingly, the matter has been re-considered by the State Government and it has been decided that the services of all such employees, who got employment on the basis of their sports achievement, shall not be terminated on the ground of their failure to have produced the Sports Gradation Certificate under the new policy till the final outcome of LPAs-1332 of 2019 (O&M) in CWP No. 23249 and other connected (O&M) - State of Haryana and another Vs Shankar and others or any further direction by the Hon'ble High Court.

4. It is also directed that the salary of such candidates may also be released in case, if it has been withheld after 31.10.2019.

5. You are, therefore, directed to ensure strict compliance of these instructions in letter & spirit and send the compliance report to General Administration Department (General Services-I Branch).

6. The instructions of even number dated 17.09.2019 already issued shall be deemed to have been modified to this extent.
