Sir/Madam,

I am directed to invite your kind attention to the Govt. letter No. 22/10/2013-1GS-III, dated 15.07.2014 on subject noted above.

2. It is intimated that Government of Haryana has assigned the Secy. Rajya Sainik Board with the responsibility to be the Nodal Department to look after and monitor the grant of reservation in jobs under Government/ Government Undertakings & Local Bodies as well as in admission in Government/Government aided educational/technical/Profession institutions in respect of Ex-servicemen and their dependents vide paragraph 11 of the Govt. policy under reference. The Haryana Rajya Sainik Board has an acute shortage of staff which will have to be created, if the Department has to undertake this fresh responsibility. In the absence of the proper set up with the Rajya Sainik Board, the State Govt. has decided that the work to monitor this task for the grant of reservations in respect of ex-servicemen will continue to be done by the Welfare of Scheduled Caste & Backward Classes
