Sir/Madam,

I am directed to invite your kind attention to the Government instructions issued vide No. 22/10/2013-1GS-III, dated 15.05.2015 and instructions issued vide No. 22/133/2013-1GS-III, dated 9.06.2015 on the subject noted above whereby inter-alia it was decided to give 20% reservation in promotion with consequential seniority to Scheduled Caste employees in Class-III and IV posts, with effect from 1st April, 2013 and it was further informed that vide orders dated 27.05.2015 the Hon'ble Punjab & Haryana High Court, Chandigarh in Civil Writ Petition No. 11073 of 2015-titled as Dinesh Kumar Sharma & Others Vs. State of Haryana has stayed the operation of the above referred instructions dated 15.05.2015 respectively.

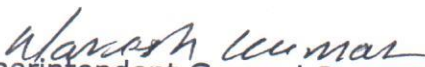

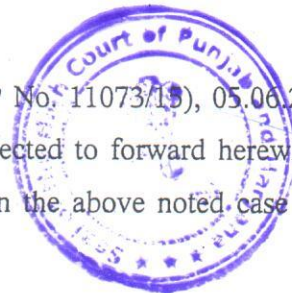
