Subject: - The criteria of re-employment after superannuation of Government Employees-Clarification thereof.

Sir/Madam,

I am directed to refer to Government Instructions No. 34/113/2018-4GSI, dated 21st December 2018 vide which attention of all Administrative Secretaries was invited towards the Council of Ministers' decision dated 15.11.2018 and it was directed to place the matter of re-employment before the CMM within two months where approval of CMM is required. Further, vide Instructions No. 46/13/2018-4FICW/23931, dated 29th October 2018, Finance Department had also issued directions to all Departments that in future, no ex-post facto approval will be given on the cases of re-employment by Finance Department.

2. It has been observed many times that cases of re-employment are being delayed by the administrative departments to be sent to Human Resources Department and Finance Department for concurrence/advice due to which, such proposal is placing before the Council of Ministers for consideration at belated stage.

3. The Council of Ministers in its meeting dated 02.02.2023 has taken a serious view in this regard and decided to streamline the process of cases of re-employment. Therefore, it has been decided that after approval of the Hon'ble Chief Minister, the case of re-employment will be sent to Human Resources Department and Finance Department immediately not more than three days later. The Human Resources Department and Finance Department will issue their advice within 15 days from the receipt of the proposal. Further, it has also been decided that agenda for the Council of Ministers shall be placed in the very first forthcoming meeting of the Council of Ministers.

4. These instructions may be brought to the notice of all concerned.
