Subject : Providing PSOs (Personal Security Officers) to Administrative Secretaries / HoDs who have been assigned districts.

As you are aware, a number of Administrative Secretaries and some Heads of Departments have been assigned districts by the State Govt. for monitoring the infrastructure, e-governance projects, schemes funded by the Central / State Govt., Covid-19 Pandemic preparedness, law and order etc. (List of designated officers enclosed). This involves visits to the districts as well as to the project sites at different places by the designated officers.

Many Administrative Secretaries / HoDs have informed me about the difficulties they have faced in the discharge of the duties assigned to them in view of the long-drawn Kisan agitation which has resulted in road jams, picketing at tolls and agitation at various Govt. offices in the districts etc. These senior officials while travelling to their assigned districts have to often negotiate such hot spots.

In view of the above mentioned facts, the matter has been duly considered by the State Govt. and it has been decided that those Administrative Secretaries / HoDs who have been assigned districts for the purposes mentioned above may be immediately provided a Personal Security Officer (PSO) by the Haryana Police to ensure their safety.

You are, therefore, requested to direct the DGP Haryana to ensure necessary action accordingly.
