Subject: Regarding grant of registration marks under GV series to the Government vehicles.

Sir/Madam,

I am directed to invite your kind attention to the subject cited above and to say that State Government has decided to grant registration marks under GV series to the vehicles registered or to be registered in the name of the Government of Haryana or its entities like Departments/Boards/Corporations etc. A notification bearing no. 12/13/2020-3T(1) dated 19.05.2022 has been issued by the Transport Department in this regard and same is enclosed herewith the reference.

2. It is, therefore directed to take immediate necessary action under the said notification within a period of 03 months, so that a registration mark under the GV series may be allotted to the existing vehicles.
3. The notification allows a class of vehicle to be exempted with the permission of competent authority.
4. These instructions may be brought in the notice of all concerned for immediate and strict compliance.

Notification

The 19th May, 2022

No. 22/13/2020-3T(I).— In exercise of the powers conferred by the Government of India, Ministry of Surface Transport, notification No. 444(E), dated the 12th June, 1989 issued under the provisions of sub-section (6) of section 41 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Haryana hereby specifies that in respect of all the Registering Authorities in the State, the group of letters allotted to the State of Haryana vide aforesaid notification followed by RTO code and further followed by the letters 'GV', generated in all series shall be exclusively reserved to be allotted to the vehicles registered or to be registered in the name of Government of Haryana or its entities like Departments/Boards/Corporations etc. Further, registration numbers from 1 to 1000 of such series shall not be available for allotment to any vehicle:

Provided that any vehicle or group of vehicles registered or to be registered in the name of Government of Haryana or its entities like Departments/Boards/Corporations etc. may seek exemption from the provisions of this notification after the approval of the competent authority.

Explanation.— "competent authority" means the Chief Minister of the State of Haryana for the purpose of this notification.
