SUBJECT: Identification of posts for the purpose of grant of Reservation in direct recruitment and Promotion to the Persons with Benchmark Disabilities under the Rights of Persons with Disabilities Act, 2016.

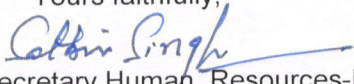
Sir/Madam,

I am directed to invite your attention to Government instructions bearing No. 22/10/2013-1GS-III, dated 25.04.2018 and No. 22/116/2018-1GS-III, dated 26.10.2018 vide which benefit of reservation in direct recruitment @ 4% was allowed to the Persons with benchmark disabilities as provided in Section 34 of the Rights of Persons with Disabilities Act, 2016. Thereafter vide instructions dated 01.07.2022 the benefit of 4% reservation in promotion was also allowed w.e.f. 19.04.2017. In the instructions of direct recruitment of 4% it was mentioned that the posts would be identified by Chief Secretary to Govt. Haryana in Personnel Department, and in the instructions dated 01.07.2022 of reservation in promotion @ 4% in para 6 the reference of list of identified posts of 3% was given.

2. Now it is clarified that for the purpose of grant of benefit of reservation in direct recruitment and promotion @ 4%, the list of identified posts notified by Government of India and adopted by Haryana Government vide notification No. 459-SW(4)-2021, dated 25.10.2021 of Social Justice & Empowerment Department, Haryana, shall be taken into account. The instructions already issued from time to time for the purpose to grant the benefit of 4% reservation to PwD shall be deemed to have been modified to this extent. The list of identified posts is available on the website of Human Resources Department, <http://csharyana.gov.in>.

3. These instructions may please be brought to the notice of all concerned for compliance in letter and in spirit.

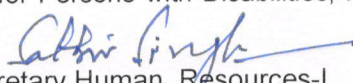
