Subject: Regarding reservation in the jobs for Sports Persons for each of Group A, B, C and D .

Sir/Madam,

I am directed to invite your attention to Government instructions bearing even number dated 30.04.2019 on the subject cited above and to say that vide notification No. G.S.R.4/Const./Art.309/2021, dated 26.02.2021 issued by the Department of Sports and Youth Affairs in which it has been decided to grant the appointment to the Outstanding Sports Persons (OSPs) in Haryana to Group A, B & C posts in the Sports and Youth Affairs Department under the Haryana Outstanding Sports Persons (Group A, B & C) Service Rules, 2021.

2. In view of adequate incentive granted by Government of Haryana under the Outstanding Sportspersons (Group A, B and C) Service Rules, 2021, the matter regarding horizontal reservation in Group A, B, C & D posts presently admissible to Eligible Sports Persons (ESPs) vide Government instructions dated 30.04.2019 has been reviewed. After careful consideration, in the matter, Government has decided that the rate of horizontal reservation for Eligible Sports Persons/Outstanding Sports Persons in Direct Recruitment posts will be as under :-
