Subject: Reservation in promotion to the employees of Scheduled Castes categories.

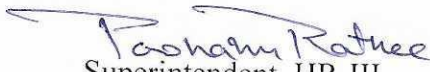
Sir/Madam,

I am directed to invite your attention on the subject cited above and to say that the Secretary, Haryana Vidhan Sabha Secretariat has stated that the Committee on the Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes held a meeting on dated 18.10.2023 at Haryana Vidhan Sabha, Chandigarh. The Committee observed that the Chief Secretary to Government, Haryana issued instructions vide letter dated 17.08.2023 to all the departments to furnish the data/information regarding inadequacy of representation to the Scheduled Castes employees and thereafter, vide instruction dated 07.10.2023, the Government has implemented the reservation policy for the promotion in the Government departments, Board, Corporation and Statutory Bodies etc. Now the Committee wants to know how many officials/officers of SC categories have been promoted during the period of 17.08.2023 to 07.10.2023.
