Subject: Information regarding reservation in promotion to the employees of Scheduled Castes categories as per instruction dated 07.10.2023 sought by the Secretary, Haryana Vidhan Sabha Secretariat on the recommendation of Committee on Scheduled Castes, Scheduled Tribes and Backward Classes.

Sir/Madam,

I am directed to invite your attention on the subject cited above and to say that Committee on Scheduled Castes, Scheduled Tribes and Backward Classes has considered the matter of reservation in promotion provided to the Schedule Castes categories employees in its meeting held on dated 18.10.2023. The Committee observed that the Chief Secretary to Government, Haryana was issued instruction dated 17.08.2023 to all the departments to furnish the data/information regarding inadequacy of representation to the Scheduled Castes employees and thereafter, vide instruction dated 07.10.2023, the Government has implemented the reservation policy for the promotion in the Government departments. Now the Committee wants to know how many employees of SC categories have been promoted during the period of 17.08.2023 to 06.10.2023 and officers/officials who have been promoted after implementation of instruction dated 07.10.2023.

2. It is, therefore, requested that desired information may be furnished to the Secretary, Haryana Vidhan Sabha Secretariat directly as per prescribed format as annexed herewith.
