Subject:- Ordinances promulgated by the Governor under the Constitution of India-
Supply of copies to the Haryana Vidhan Sabha Secretariat.

Will all the Administrative Secretaries to Government, Haryana kindly refer to the subject noted above?

2. It has been observed that the copies of the Ordinances which are required to be laid on the Table of the House are not sent well in time to the Haryana Vidhan Sabha Secretariat to meet the requirement of Rule 168(1) and (2) of the Rules of Procedure and Conduct of Business in the Haryana Legislative Assembly, which provides as under:-

“168. (1) As soon as possible, after the Governor has promulgated an Ordinance under Article 213(1) of the Constitution, copies of the Ordinance shall be made available to the members.

(2) A member desiring to move a resolution under sub clause (a) of Clause (2) of Article 213 of the Constitution disapproving an Ordinance promulgated under clause (1) of that Article shall give three days notice of his resolution to the Secretary.”

3. In view of this, you are requested to intimate as to whether any Ordinance has been promulgated by the Governor, Haryana, during the inter Session period i.e. after March (Budget) Session, 2023 to till date. If so, you are requested to supply 200 copies each in Hindi and English alongwith two authenticated copy each of the Ordinance(s) to the Haryana Vidhan Sabha for taking further necessary action in the matter.
