Subject:- Grant of financial assistance to the Haryana State Freedom Fighters/INA Personnel and their widows for the marriage of their grand-daughters.

Sir/Madam,

In continuation of the Government letter of even number dated 20.8.2009, I am directed to refer to the subject noted above and to inform you that the Government has introduced the financial assistance scheme @ Rs. 2000/- to the Haryana State freedom fighter/INA personnel and their widows for the marriage of their daughter and dependent sisters, vide Government letter of even number dated 26-6-1984. Thereafter vide Government letter dated 20-8-2009, the financial assistance was revised to Rs. 51000/- and assistance was further extended to the Haryana State freedom fighters/INA personnel and their widows for the marriage of their grand-daughters.

2.. However, it has been observed that the claim cases are received very late. So the matter regarding rationalization of time period for the financial assistance has been under consideration of the Government ..

3. Now it has been decided that the claim for the financial assistance for the marriage of grand-daughters of the Haryana State freedom fighter/INA personnel and their widows @ Rs. 51000/- ordinarily be made within 6 month from the date of marriage but not later than 12 months (for a special reason to be recorded for delay) through the concerned Deputy Commissioner.

4. It is further reiterated that after verification of claims and recording his/her satisfaction, D.C. will forward the case to Chairman/Haryana Swatantrata Sainani Samman Samiti. (HSSSS). After verification by Chiarmen, HSSSS, approval will to be taken from Chief Secetay to issue sanction to the Administrator General & Official Trustee & Treasurer, Charitable Endownments Haryana for making necessary arrangement for payment of financial assistance.

5. It is also mandatory from now onwards that financial assistance shall be provided only through Aadhaar linked bank accounts.
