Sub:- Grant of Financial Assistance to the Freedom Fighters/
INA personnel and their widows of Haryana State.

Sir,?

I am directed to refer to Haryana Government letter No. 49/16/4PP-83, dated 15th March, 1984 on the subject noted above and to say that it has been further decided that the grant of financial assistance to Haryana State Freedom Fighters/ INA personnel and their widows for the marriages of their daughters and dependent sisters may be given to the tune of Rs. 2000/-only (Rs. Two thousand only) in each case even though more than one marriage to be solemnised in a year.

2 It is also clarified that the S.D.M./G.A. to D.C. after their verification and satisfaction will forward the case to the Chairman, H.S.S.S.S.. He after due check of the particulars of Freedom Fighters, will forward to the Member-Secretary of the Committee. On the recommendations of the Chairman, H.S.S.S.S. and with the approval of Chief Secretary, the sanction will be issued to the A.G.O.T. for making necessary arrangements for payment.

3 It is also clarified for the payment of Rs. 500/-as funeral charges to the dependents of Freedom Fighter, the S.D.M. concerned after his satisfaction about the death of the Freedom Fighter, will recommend the case to the Chairman, H.S.S.S.S. for release of funeral charges within four days of the receipt of information of the death of the Freedom Fighter. The requisite sanction will be issued by the Government to A.G.O.T. who will disburse the amount within 10 days.

4 I am, therefore, to request you that all freedom Fighters of your respective district may kindly be informed, accordingly by

giving it wide publicity by you so that they can avail of these concessions.
