Subject: Entitlement of Vehicle for Govt. officers appointed to Statutory, Non-Statutory, Constitutional Bodies, Commissions, Authorities etc. post retirement.

Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that due to non-availability of any specific provision regarding entitlement of staff car for the use of govt. officers appointed to Statutory, Non-Statutory, Constitutional Bodies, Commissions, Authorities etc. post retirement different types of vehicles are being purchased for their use.

2. After careful consideration Government has decided that whenever any government officer (including an All India Service Officer) after retirement is re-employed/appointed to any Statutory, Non-Statutory, Constitutional Body, Commission, Authority, etc. under Haryana Government he/she shall be entitled to a staff car, the cost of which shall be upto 10 times of the last basic pay drawn by him/her subject to a maximum ceiling of Rs. 20.00 lakh (excluding taxes).

3. However, if he/she does not want to avail the facility of staff car he/she may perform journeys in his/her private vehicle (*with own Driver*) and in lieu thereof road mileage allowance @ Rs. 18/- per km shall be admissible for journey under taken on official duty at headquarters and outside the headquarters upto a total limit of 5,000 kms in a calendar month. Journeys in excess of 5,000 kms in a calendar month however shall be treated as private journeys.

4. These instructions may kindly be brought to the notice of all concerned.
