Sir/Madam,

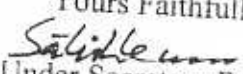
I am directed to invite your kind attention to this department letter No.'s 2/6/2005-RVA, dated 21.7.2005, 24.03.2006 and the letter of even number dated 2.5.2007 on the subject noted above, where in the decisions of the Government, regarding purchase of vehicles/cars by the Government Departments, Boards, Corporations were conveyed.

2. Now it has been decided by the Government that concerned Departments of the Govt. /Boards/Corporations etc. may take their own decisions for selection of the Models /Categories of Cars/Vehicles, which are to be purchased by them. It is clarified that these vehicles as per entitlement may be purchased as and when a vehicle is condemned i.e. replacement vehicle is to be bought or sanction for purchase of new/additional vehicle may be obtained from all quarters as per procedure and Government instructions. The instructions of the State Govt. for entitlement of price range for the officers of the Govt. Departments /Boards/Corporations etc, which have already been conveyed vide letter No 2/5/2007-RVA dated 07-08-2007 may be kept in view. However it is re-iterated as under:-

A	For officers holding the posts of Financial Commissioners & Principal Secretaries/ Commissioner & Secretaries.	Upto Rs. 6 Lacs inclusive of all taxes
B	Special Secretaries / Joint Secretaries/ Head of Departments / Managing Directors of Boards/ Corporations.	Upto Rs. 5 Lacs inclusive of all taxes
C	For officers other than Head of Departments/Managing Directors of Boards/ Corporations.	Upto Rs. 4 Lacs inclusive of all taxes.

The above instructions may strictly be adhered to while purchasing the opted Models/Categories of Cars/Vehicles for Govt. Deptts /Boards/Corporations etc.

You are, therefore, requested to bring these instructions to the notice of all concerned working under your control for compliance.

Sir/Madam,

I am directed to invite your kind attention to this department's letter No.'s 2/6/2005-RVA, dated 21.7.2005, 24.03.2006, and the letter of even number dated 2.5.2007 on the subject noted above, where in the decisions of the Government, regarding purchase of staff vehicles/cars by the Government Departments/ Boards/ Corporations etc. were conveyed.

2. Now it has been decided by the Government that concerned Departments of the Govt. /Boards/Corporations etc. may take their own decisions for selection of the Models /Categories of Cars/Vehicles, which are to be purchased by them. It is also clarified that these vehicles as per entitlement may be purchased as and when a vehicle is condemned i.e. replacement vehicle is to be bought or sanctioned for purchase of new/additional staff vehicles may be obtained from all concerned quarters as per procedure and Government instructions. The instructions of the State Govt. for entitlement of price range for the officers of the Govt. Departments /Boards/Corporations etc, which have already been conveyed vide letter No 2/5/2007-RVA dated 07-08-2007 may be kept in view. However it is re-iterated as under -

1	For the officers of super time scale and above.	Upto Rs. 6.00 Lacs inclusive of all taxes
2	For the officers at the level of Head of Departments/Managing Directors /Selection Grade officers.	Upto Rs. 5.00 Lacs inclusive of all taxes
3	For the officers other than Head of Departments/ Managing Directors /Selection Grade officers.	Upto Rs. 4.00 Lacs inclusive of all taxes.

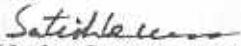

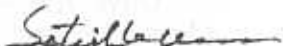
