

Subject:- Writing of Performance Appraisal Reports of IAS officers on deputation to State Corporate Bodies/Agencies.

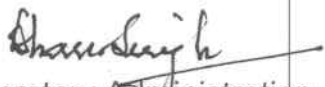

i) Immediate superior officer, if any.	Administrative Secretary	Chief Minister
ii) Administrative Secretary (if the immediate superior officer is junior to the officer reported upon.)	Minister-in-Charge	Chief Minister

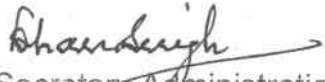

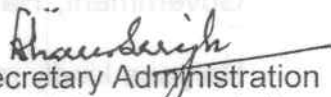

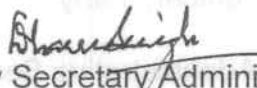
