Sir/Madam,

I am directed to communicate that 05 posts of Addl. Dy. Cm./Jt. A&C under deputation quota are vacant and few posts are anticipated to fall vacant in the near future. The post of Addl. Dy. Cm./Jt. A&C is in the pay scale of Rs.15600-39100 + GP 7600. **As per proposed RRs to the post, Officers of the Central/State/UT/Govt. Services**

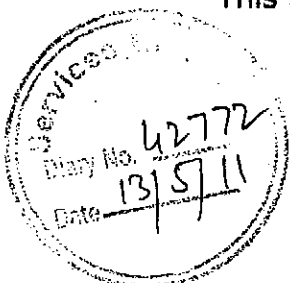
- (i) Holding analogous post on regular basis in the parent cadre/department, or
- (ii) With 5 years regular service in the scale of Rs 15600-39100+Grade Pay Rs 6600/- in the parent cadre/department

are eligible for the post. (Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department shall ordinarily be 3 years but shall not exceed 5 years).

Since, the MCD follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable **mutatis mutandis** to the officer on deputation basis.
