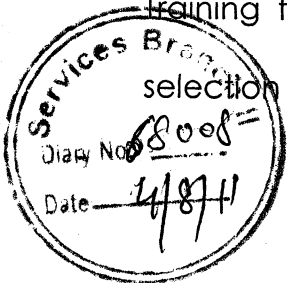
Dear Chief Secretary,



The Ministry for the Development of the North Eastern Region is mandated to take up the special developmental concerns of the seven North Eastern States and Sikkim. We propose to implement a livelihood promotion project for the rural poor in selected areas of four States of Tripura, Sikkim, Nagaland and Mizoram for which funding from the World Bank is being obtained. The proposed project – North East Rural Livelihood Project (NERLP) – will be a Central Sector Project under this Ministry and implemented through an autonomous registered society – North East Livelihood Promotion Society – located at Guwahati. The Project Director will be the Chief Executive of the Society.

2. We desire to appoint a suitable IAS officer of seniority between 13 to 25 years with requisite vigilance clearances as Project Director of NERLP to design the detailed project report and also implement the same. The selection of the officer will be done as per extant guidelines of the Department of Personnel and Training for posts under non-Central Staffing Scheme through a search-cum-selection committee. It will have a normal tenure of five years.
