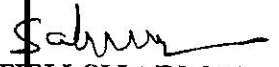

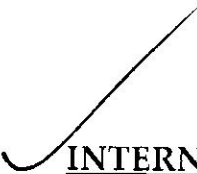

CIRCULAR

Sub: Recruitment to one post of Director (Institute) in the Indian Institute of Handloom Technology, under the Office of the Development Commissioner for Handlooms, Ministry of Textiles 'by Transfer on Deputation (including short-term contract)' – regarding.

Services of suitable officer are required for appointment to one post of Director (Institute) on 'Transfer on Deputation (including short-term contract)'.

The scale of pay of the post is Rs.15600-39100/- (Pay Band-3) + Grade Pay Rs.7600/-. Selection of the eligible officer for the post will be made by UPSC from amongst officers under the Central or State Governments or Public Undertakings or Autonomous Bodies or Corporations –

- (a) holding analogous or equivalent posts or with 5 years service in posts in the scale of Revised Rs.15600-39100/- (Pay Band-3) + Grade Pay Rs.6600/- or equivalent ; and
- (b) possessing the educational qualifications and experience prescribed for direct recruits, as indicated in Annexure-I at www.handlooms.nic.in.

2. Period of deputation or contract shall ordinarily not exceed 04 years. The terms and conditions of deputation will be regulated according to the orders contained in the Ministry of Finance O.M. No.10/2/24/E.III/60, dated 4.5.1961 as amended from time to time and DOPT's O.M. No.6/8/2009-Estt.(Pay II), dated 17.06.2010. The terms of the officers coming from the Public Sector Undertaking will be regulated in accordance with Department of Personnel and Administrative Reforms O.M. No.1/4/84/Estt.P.II dated 26.12.84, as amended from time to time and in the case of those coming on contract, the terms will be settled in consultation with the concerned authority.

3. Ministry/Department of Central/State Government/Union Territories are requested to kindly bring this vacancy to the notice of the officers working under them and in the Public Undertakings/Autonomous Bodies/Corporations under their administrative control.

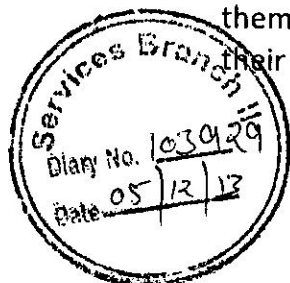

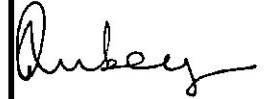
