Filling up of two (02) posts of Deputy Agricultural Marketing Adviser (Group - III) in Directorate of Marketing & Inspection, an Attached Office under Department of Agriculture & Farmers Welfare, on deputation (including short term contract) -reg.

It is proposed to fill up two (02) posts of Deputy Agricultural Marketing Adviser (Group-III) in Level 12 of Pay Matrix (pre revised pay scale of Rs. 15,600-39,000/- with Grade Pay of Rs. 7600/- in Pay Band-3) in Directorate of Marketing & Inspection, an Attached Office under this Department through deputation (including short term contract) basis.

2. Following officers under the Central/State Governments/ Universities/ Recognized Research Institutes/Public Sector Undertakings/ Autonomous or Statutory Organizations/ State Agricultural Marketing Boards/ Societies or Cooperative Societies aided by the Central/State Governments are eligible:-

- (a) (i) holding analogous post on a regular basis in the parent cadre/ Department;
or
(ii) with five years' service in the grade rendered after appointment thereto on regular basis in Level-11 of Pay Matrix (Rs. 67700-208700)- in the parent cadre or Department; and

- (b) Possessing following educational qualifications and experience:-

Essentials:-

- (i) Master's Degree in Chemistry / Agriculture Chemistry / Dairy Chemistry / Dairying/ Biotechnology/Biochemistry from a recognized University;

OR

Bachelor of Technology Degree in Oil Technology/Food Technology/Chemical Technology/Dairy Technology from a recognized University.

- (ii) 10 years' experience in the field of analytical work of organic material, or in the field of Marketing of Milk and Milk Products, Oils and Fats including Essential Oils and allied commodities.

OR

8 years' experience in the field of analytical work of organic material or in the field of Marketing of Milk and Milk Products, Oils and Fats including Essential Oils and allied commodities including diploma in Marketing Management awarded by any recognized university or Institute or equivalent.

Note 1 : Qualifications are relaxable at the discretion of the Union Public Service Commission in the case of candidates otherwise well qualified.

Note 4: Period of deputation (including short-term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not to exceed four years.

Note 5: The maximum age limit for appointment by deputation (including short-term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.

3. The officers selected on 'deputation' basis will have the option to draw his grade pay plus deputation (duty) allowance or to have his pay fixed in the scale of the post in accordance with DOP&T's OM No. 2-11/2017-Estt. (Pay-II) dated 24.11.2017, as amended from time to time.

4.
