(iii) with minimum eight years' service in the grade rendered after appointment thereto on a regular basis in Level 12 (Rs. 78800-209200/-) of the Pay Matrix or equivalent in the parent cadre or Department; and

(b) Possessing the following educational qualifications and experience:

(i) Essential: - Graduate Degree in Civil Engineering or Environmental Engineering/Technology from recognised University or equivalent; and

(ii) Fifteen years of working experience in the field of Water Resources Management, construction, operation & maintenance of pollution abatement project.

Desirable: - M.E./M.Tech in Environment Engineering/ Public Health Engineering/ River & Lake conservation/ Water Resources/ Hydrology/ STP

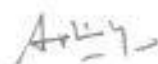
3. The total period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed five (05) years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.

4. The officer selected will have the option to draw his pay in the pay matrix plus deputation (duty) allowance or his pay fixed in the pay matrix of the deputation post subject the restrictions contained in the Department of Personnel & Training (O.M. No. 6/8/2009-Estt.(Pay II) dated 17.06.2010) as amended from time to time.

5. It is requested that wide circulation may be given to the post and applications of eligible and willing officers, in triplicate duly filled and signed by the officer concerned in the enclosed proforma (Annexure A) & countersigned by the sponsoring authority along with requisite certificate/documents may be forwarded to the undersigned within 30 days from the date of publication of this circular in the Employment News. While forwarding the applications the sponsoring authority may certify that (i) particulars given by the applicant are correct (ii) integrity certificate/ no penalty statement /no vigilance/ disciplinary case is either pending or contemplated against the applicant (iii) in case of selection, the officer will be relieved for taking up the new assignment and (iv) photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary or equivalent. **The candidates who have already applied in response to the advertisement published in Employment News edition 29th May – 04th June, 2021 and 22nd October – 28th October 2022 are not required to apply fresh**
