- (5) The applications in **prescribed proforma** of eligible and interested officials, alongwith a certificate to the effect that they are clear from Vigilance angle, their integrity certificate, details of major/minor penalty imposed on them during the last 10 years and attested photocopies of their ACRs/APARs for the last 5 years, be forward to the Haryana State Pollution Control Board, C-11, Sector-6, Panchkula by **20.04.2023**.
