Subject-Filling up the post of Nazim in Dargah Khwaja Saheb, Ajmer on deputation basis - regarding.

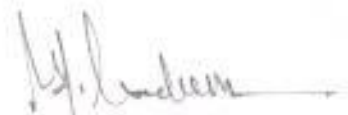
The undersigned is directed to inform that the Ministry of Minority Affairs, Government of India invites applications from eligible candidates for the post of Nazim, Dargah Khwaja Saheb, Ajmer, which is a statutory body under the administrative control of the Ministry of Minority Affairs. The post will be filled on the foreign deputation basis and officers who fulfill the following criteria may apply to the said post;

Essential Qualifications and Experiences	The candidate should: a) Be a person serving in a post equivalent to a Deputy Secretary (Level-12) in the Central Government / State Government / Central or State Autonomous Body/Public Sector Undertaking/ Armed Forces/Central Para-military Forces, or b) Having at least 5 years service in the post at the pay level - 11, with experience of administrative, legal, revenue and financial matters to allow him to liaison with different Departments of the Central Government and the Rajasthan Government. c) Be a Hanafi Muslim and a citizen of India, d) Be a devotee of Khwaja Saheb, Ajmer; and e) At least a graduate from a recognized university with working knowledge of Urdu.
Age:	The age of the officer should not be more than 56 years at the last date for submission of the application. Relaxation in deserving cases will be given subject to fulfillment of essential qualifications and experience detailed in paragraph 1 above.
Desirable Qualifications:	Candidates belonging to an organized Central or State Service/ Armed Forces/ Central Para-Military Forces and having experience in handling legal, administrative, revenue and financial matters will be preferred.
Tenure:	The initial appointment for the period of two years. The term of appointment can be extended from time to time but in no case will such a person be allowed to continue to function as Nazim beyond the age of 60 years.

Pay & Other Allowances:	The pay of an officer serving in the Central Government / State Government / Central or State Autonomous Body / Public Sector Undertaking / Armed Forces / Central Para-Military Forces, if selected for appointment as Nazim, will be protected. He will earn increments in this pay level during the time, he will be appointed as Nazim as per rules of the Central Government. However, the service as Nazim is non-pensionable.
Accommodation:	Rent-free accommodation will be provided to the Nazim at Ajmer.
Conveyance:	A car is placed at the disposal of the Nazim to allow him to perform his official duties.
General Conditions:	a) The candidates presently employed in the Central Government / State Government / Central or State Autonomous Bodies / Public Sector Undertakings / Armed Forces / Central Para-Military Forces, must apply through proper channel with Cadre and Vigilance clearance. b) The candidates when intimated will be required to present themselves for a personal interview. c) The Ministry of Minority Affairs reserves the right to relax the qualifications / experience and age limit for outstanding and exceptionally deserving candidates.
How to apply:	Duly filled prescribed application form and signed (applications in original) through proper channel with forwarding letter should be sent to reach the authority mentioned below within 30 days from the date of publication of advertisement.
