2. The terms & conditions of appointment of the above officer will be issued separately.

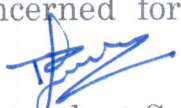

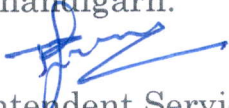

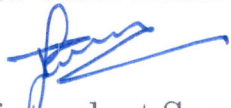
