Naris' meet at Meham on 4-10-2008. It has been decided that the present rate of

disabled ex-servicemen whose disability has been assessed above 50% and orphan
daughters of ESM has been increased from Rs. 11,000/- to Rs. 21,000 w.e.f. 4 Oct. 2008.
It is however, clarified that performa grant will remain the same.
