Subject:- Policy for engaging / outsourcing of services / activities – clarification regarding payment of wages to the persons engaged under Part-II of the Policy.

Sir/Madam,

I am directed to invite your attention to the Haryana Government circular letter No. 16/7/2015-3GS-II, dated 06.04.2015 wherein the General Administration Department had fixed the wages of contract employees uniformly across the State on formula of 50% of initial pay (Pay in Pay Band + Grade Pay + DA) of fresh entrant Regular Employee after 01.01.2006, subject to minimum of Rs. 8100/- per month.

2. However, many departments are seeking advice whether the higher DC rates than the rates fixed vide letter No. 16/7/2015-3GS-II, dated 06.04.2015 can be allowed to the Outsourced employees engaged under Part-II of the Outsourcing Policy or otherwise.

3. After due consideration, it has been decided that the salary / wages of contractual employees engaged under clause (i) of Part-II of the Outsourcing Policy dated 06.04.2015 shall be fixed as per existing formula i.e. 50% of initial pay (Pay in Pay Band + Grade Pay + DA) of fresh entrant Regular Employee after 01.01.2006, subject to minimum of Rs. 8100/- Or on the wages fixed by the concerned Deputy Commissioners under the provisions contained in Finance Department's Notification No. 7004-F-41/60571 (Fin-Gen), dated 21.11.1941, whichever is higher.

4. This issues with the concurrence of Finance Department conveyed vide U.O. No. 1/89/2011-5PR(FD), dated 27.05.2016.
