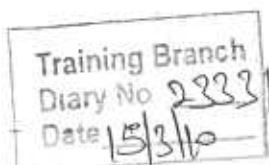

TRAINING CIRCULAR

Subject: An Area Focussed Training Course in Community Capacity and Rural Development Promotion in Asia Countries – One Village One Product – to be held in Japan from 13th June, 2010 to 3rd July, 2010 under the Technical Cooperation Programme of the Government of Japan.

The Government of Japan have offered the above noted training programme. Copies of the training brochure and application forms may be accessed from Finance Ministry website. The Government of Japan will provide round-trip air fare, accommodation allowance and the living allowance.

2. This programme is designed for central/rural governmental organizations involved in the planning, promotion and evaluation of regional development and local industry promotion projects.

3. The number of slot available to India is **one**. The number of nominations to be sent to this Department may not, therefore, exceed **one regular and one reserve**.

4. The nomination of suitable candidates may be done in accordance with the Department of Economic Affairs' O.M.No.1/13/03-PMU, dated 27.2.2006. The nomination details should be submitted on the following:

- (i) Prescribed Application Form together with the medical history questionnaire.
- (ii) DEA's prescribed proforma – duly countersigned by competent authority.
- (iii) The Inception Report.

5. Last Date of Submission: The completed 'application form' should reach this Department not later than **05.04.2010**. Nomination received after the prescribed date will not be considered.
